North Texas Higher Education Authority, Inc. (the "Authority") announced today that the Supplemental Indenture dated as of January 1, 2020 between the Authority and BOKF, N.A., as trustee and eligible lender trustee, became effective on February 26, 2020. The Supplemental Indenture permits an early redemption of the bonds at a price of 101.5% of outstanding principal plus accrued interest to the date of redemption.
